

### ARTICLES OF INCORPORATION

#### NAME:

The name of this corporation shall be the Joint Office of Citizen Complaints.

#### PRINCIPAL OFFICE:

The place in this state where the principal office of this corporation is to be located is the City of Dayton, Montgomery County, Ohio.

#### **PURPOSES:**

This corporation is formed and shall be operated exclusively for the following charitable and educational purposes:

- 1. To provide investigative services of administrative acts of agencies upon complaint by any citizen.
- 2. To provide convenient public service to assist individual citizens in getting fair treatment from governmental agencies.
- To provide an impartial agency for investigating citizen complaints concerning services of governments and governmental agencies.
- 4. To further improve citizen confidence in local government services.
- 5. To generate public information through the media which will lead to better community understanding of urban dilemmas.
- 6. To provide an opportunity for constructive public service by volunteers.

#### RESTRICTIONS ON CORPORATE ACTIVITY:

No charge shall be made by this corporation for any service rendered to complaining citizens. No substantial part of the activities of this corporation shall attempt to influence legislation. This corporation shall not participate in any political campaign on behalf of any candidate for public office.

#### MEMBERSHIP:

Any political subdivision in the Dayton, Ohio metropolitan area shall be eligible to become a member of the corporation upon the affirmative vote of not less than a majority of the Board of Trustees. The initial members of this corporation shall be the City of Dayton, Ohio, the Dayton School District, and Montgomery County, Ohio.

#### TRUSTEES:

The affairs of the corporation shall be governed by a Board of Trustees. Each member of the corporation shall elect three trustees.

#### OMBUDSMAN:

The Board of Trustees shall elect an Ombudsman to be the chief executive officer of the corporation. There is a Management Agreement by which the Ombudsman is retained through a contractual agreement with the Board of Trustees. This agreement limits any interference by the members of the trustees in the ordinary conduct of business of the Ombudsman's Office. It further states that, if the Ombudsman shall breach any of the terms of the agreement, she/he may be removed from office by only the affirmative vote of two-thirds of all the trustees in office. The Board of Trustees shall have authority to delegate the general supervision and control of the affairs of the corporation to the Ombudsman.

## OMBUDSMAN'S MESSAGE 2018



The core work of the Ombudsman Office is handling hundreds of complaints and inquiries, and we are committed to building on this work as we enter into our 48<sup>th</sup> year. In 2018 the office handled 601 complaints about government agencies and 428 cases about long term care facilities. The largest category of cases concerning government agencies continues to be access to Medicaid coverage, followed by access to food assistance. The populations served in these cases are primarily children and the elderly. As the reader may see in our statistics, our cases and the information and referrals we supply cover most government agencies in our county. The largest category of cases for our Long Term Care Ombudsman program are unwanted discharges or evictions from facilities, and failure to respond to requests for assistance. A great deal of staff

time is spent on preventing unwanted discharges, sometimes even to homeless shelters.

It is our practice to work to solve problems at the lowest possible level. We work to obtain a solution within the organization or community where the complaint lies. Our quick resolutions are enhanced by patient listening to complainants, creative thinking and problem analysis, and knowing who has the ability to bring resolution to the problem.

We conduct a satisfaction survey after each case about a government agency is closed in order to ensure that our resolutions to the problems are lasting. Overwhelmingly, those who visit or call our office are satisfied with the outcome of our work. Even those who do not achieve what they were seeking at least understand the policies and reasons. When asked where they would have turned if the Ombudsman Office were not present, the overwhelming response is "I don't know." The comments include gratefulness for the office; appreciation for our work; our follow-through and the rapidity with which we achieve resolution.

I look forward to 2019 and to increasing awareness of our office and the work that we do, whether we are informing people about a relatively new jurisdiction of the My Care Medicaid program or our ongoing work with government agencies. We will continue to seek to educate the public and our stakeholders through the weekly newspaper column in the Dayton Daily News, our monthly television program on DATV, the Ombudsman Office Weekly Update and through presentations at community events.

I want to thank our Board of Directors for giving the residents of Montgomery County an Ombudsman Office through their funding and support; our wonderful staff who are dedicated advocates for good government and good care; our dedicated volunteers and interns; and the residents of Dayton and Montgomery County.
